Global warming still the hot topic discussed by World Meteorological organization in year 2023. Refer to "State of the Global Climate in 2022" reported by WMO was shown that the years 2015 - 2022 were the eight warmest on record, despite the cooling impact of a La Nina event for the past three years. Antarctic sea ice fell to its lowest extent on record, and the melting of some European glaciers was, literally, off the chart. The condition of global warming is getting worst now.

In "Global Annual to Decadal Update", the first point prediction suggest is "The annual mean global near-surface temperature for each year between 2023 and 2027 is predicted to be between 1.1°C and 1.8°C higher than the average over the years 1850-1900." Do not look down on such little degree of increasing, it will bring a huge impact to us. Example: the study and prediction from "Nature Communications", 8 states in Malaysia (Perlis, Kedah, Pulau Pinang, Perak, Negeri Sembilan, Pahang, Kelantan and Sarawak) may impact of flooded and disappear from the map of Malaysia in such extreme heat. (News reported on 16 May 2023 by "Samudera.com").

So, always think "Green" when we want to do any planning and improvement in our daily operation. So that can reduce the emission of CO2 in order to cool down our earth.

ENVIRONMENTAL AUDIT

Sumirubber Malaysia Sdn Bhd has conducted the internal audit for Environmental Management System (ISO 14001: 2015) on 19th to 22th April 2022. Opening & Closing meeting organized virtually due to Covid-19. The four days audit covered various departments and environment-areas in Sumirubber Malaysia.

Internal Audits is an Environmental Management System's best friend. Audit findings lead to great improvement in the effectiveness and efficiency of the system. This is also to ensure that both the term and results of the environmental system's objectives are met and recorded.

Audit was carried out by 14 qualified auditors including lead auditor. All nonconformities and observations were recorded and resolved by the related departments.

The main objective is to administer, demonstrate, implement and monitor the environmental management system activities and continual improvement.




CONSERVATION OF ENERGY




















<u>Remarks</u>

CSR ACTIVITIES Mangrove Tree Planting

Sumirubber Malaysia Sdn Bhd in collaboration with Kedah Forestry Department has successfully cultivated a love for conserving the mangrove and has carried out external mangrove tree planting on 25th September 2022.



About 500 forest trees were planted in Sungai Limau, Yan, and Kedah. Mr Hiromasa Okubo as Managing Director has led this program. This programmed was first initiated in the year 2014 and was successfully continued as an annual activity.

It is part of our responsibility to maintain and constantly plant trees to restore the deforested area hence creating a balance ecological system.

100 employees were selected from various departments to participate in this activity.

Deputy Director of the Kedah State Forestry Department, Mr. Zainuddin Jamaluddin quote that the planting of trees is important in protecting the coastline from the threat of erosion by strong waves in addition to preserving the ecosystem in several areas in the state.

On top of that, Kedah Forestry also carried out work to treat mangroves and planted as many mangrove saplings.

A truly special kind of connection with nature was experienced by all the participants, especially after almost 2 years of restriction by Malaysia Government due to the Covid-19 pandemic.

CSR ACTIVITIES Glove Donation for Flood Relief

In the middle of July 2022, an area in Baling, Kedah was affected by a sudden disaster. For the first time, a huge flood which has caused fatality and property loses happened in this area.

A total of 1,424 victims from 93 families have been relocated from their homes, 3 casualties reported including a pregnant mother, and 802 houses were destroyed and badly damaged.

Sumirubber Malaysia has taken this opportunity to initiate this donation purposely to help post-flood victims, especially during their cleaning phase.

With approval from Management, Sumirubber team prepare 40 cartons of gloves for donation. Gloves were selected from the disposable, household, knitted working gloves and fully dipped working gloves.

On 15th July 2022, Sumirubber team went to deliver glove as a donation to Baling District Office, Volunteers Centre and villagers house nearby Kampung Iboi, Baling. The donation starts from 9.00am.

The donations was presented by Operations Director Mr. Junichiro Hoshikawa together with Mr. Mohd Amin, HRGA Manager, and Mr. Ruzaimi, Safety Manager.

Yearly Emergency Response Team (ERT) training was conducted in collaboration with Fire and Rescue Department of Malaysia (BOMBA) Tikam Batu this year. Meanwhile fire drill exercise for Sumirubber Malaysia was done on 01.06.2022 and 29.12.2022. Our ERT team successfully managed to control the excercise at new designated assembly area (near main gate) for 473 employees in 3.19 minutes time frame.


